
KEY PERFORMANCE DATA FOR 2022



The recent energy crisis has illustrated the need for a more efficient and closer link between electricity production and consumption. We are therefore **reinforcing our development paradigm with the aim of**:




generating cash flow through the production and reliable supply of our customers, and via international trading, and funnelling that cash flow into




RELIABLE SUPPLY OF CUSTOMERS

Customers are the central focus of operations: we are the most trustworthy supplier of low-carbon electricity on the Slovenian market. We are opening opportunities for demand response via innovative development services. As the most reliable partner in the implementation of the green transition, we are strengthening the competitiveness of the Slovenian economy and the public sector.





We are creating investment potential by **optimising the sale** of produced electricity on the retail market, while exploiting opportunities on the wholesale markets to increase added value.

2 INVESTMENTS IN NUCLEAR TECHNOLOGIES



The core development project of the GEN Group is the construction of a second nuclear power plant unit (JEK2), which will facilitate long-term energy independence.

As the bearer of the nuclear energy option in Slovenia, GEN actively monitors the **international development of nuclear technologies**, and monitors the development of medium-sized and **small modular reactors (SMR)**.






INVESTMENTS IN RENEWABLE ENERGY SOURCES, FLEXIBILITY AND ADVANCED SERVICES

We are taking decisive steps on the path to the green transition and sustainable development through the planning of:

- investments in the construction of new production capacities to increase the share of renewable energy sources (RES): solar, hydro and wind;
- investments in the construction of new capacities for the management of flexibility; and
- advanced sustainable energy cycle and energy community services.

Through investments in RES, we are making a significant contribution to the achievement of the national goals of decarbonisation and an increased share of RES, which are part of Slovenia's commitments defined in the comprehensive National Energy and Climate Plan (NECP).




